**NOTES:**

1. Odd numbers are cage 1 (BOYS) even numbers are cage 2 (GIRLS)
2. All times are for a period of one (1) hour only.
3. Requests for OPEN times are made to me on a first come, first serve basis; no more than one (1) week in advance.
4. Schedule will be posted on the Dehaven website [dehavenaa.org](http://dehavenaa.org)
5. Please obey all posted rules. ***Specifically: No warm-up (bat swinging) outside the cage doors, no throwing or playing catch outside the cages.***
6. Bats may be swung in the Warm-Up Area Only. Only one (1) player (helmet must be worn) is permitted in the warm-up area at a time.
7. Please ask teams to schedule in two (2) shifts (i.e. If cage time is 5 PM, 1/2 team should report to cages at 5 PM, the second 1/2 at 5:30 PM). This should help cut back on problems due to thrown balls, playing catch, swinging bats outside of warm-up area, etc. in the batting cage area.
8. The cages are to be closed & locked no later than 9:30 PM.
